Use of the Internet is a privilege, not a right. *The Board of Education's Internet and network connections are provided for teacher-directed educational purposes only. Unauthorized and inappropriate use will result in a cancellation of this privilege.*

The Board has implemented the use of a Technology Protection Measure which is a specific technology that will protect against (e.g., block/filter) Internet access to visual displays that are obscene, child pornography or harmful to minors.
